**Abstract.** An abstract should contain a short overview of the article content, problem and the relevance of the research, research methods and the results obtained. The text of an abstract must be clear and concise. The length of an abstract is 2000 – 2200 characters.

**Keywords:** no more than 5 keywords.

### **Introduction**

The annual journal „Optimization of Ornamental and Garden Plant Assortment, Technologies and Environment“ publishes original, previously unpublished papers of scientists, teachers, practitioners and students in Lithuanian or English language. The publication is included in international scientific information databases CAB Abstracts, CABI Full Text, EBSCO Publishing. This is a peer-reviewed scientific journal (ISSN 2029-1906, online ISSN 2335-7282) published since 2004 once per year. Scientific articles are published free of charge.

We are looking forward to the preparation of articles and one review (free or recommender form) by email [deko@go.kauko.lt](mailto:deko@go.kauko.lt). The second reviewer will be appointed by the journal Editorial Board. The articles that meet the requirements of the publication and are corrected according to the reviewer's remarks, will release current year until April 30. The journal you can find at website, by address: <http://www.zak.lt/mokslo-darbai/>. Articles can be in the following fields of sciences agricultural or technology.

### **Submission procedure of the articles**

The articles submitted to the editorial board must be written in scientific language. Information presented should be edited, without spelling, punctuation and style errors. The length of the article is 7 to 8 pages. Articles are accepted for publication only upon the fulfilment of all the conditions described below:

1. The electronic version of the articles in word format should be send to the following address: [deko@go.kauko.lt](mailto:deko@go.kauko.lt)

2. The authors are responsible that the article provides original research data and its content and the authorship is agreed with co-authors. The contributors of the article must send the signed original letter of Author's guarantee.
3. Two reviewers are assigned to the article, corresponding to the formal and scientific requirements. One review of paper can be chosen by the author himself, the second reviewer is appointed by the editorial board. They submit the article reviews within 2 weeks. If necessary, the article with reviews is sent back to the author for correction and must be revised and returned within 2 weeks. The names of the reviewers are not disclosed to the author. If the author does not agree with the essential remarks of reviewers, he/she submits a written response to the editorial board.
4. The reviewed article is published on the approval of the journal's Editorial Board.

### Requirements for the structure of articles

The following parts should be distinguished in the layout of the article:

1. **TITLE OF THE ARTICLE.**
2. **Author(s)**, *institution*, represented by the author(s).
3. **Abstract.** The abstract should contain a short review of article content, problem and the relevance of the research, research methods and the results obtained. The text of an abstract must be clear and concise. The length of an abstract is 2000– 2200 characters.
4. **Keywords:** 3-5 keywords, expressing the most important features of the topic, should be given under the abstract.
5. **Introduction** - the problem of the topic, its relevance and analysis of literature, formulated the aim, object and objectives of the research.
6. **Methodology (methods).** Describes where and when the research was conducted, the methods used in the study and other information related to the study.
7. **Results.** The research results and their discussion are presented. The results can be presented with the help of tables and / or graphs. Tables and graphs must be numbered, have titles, the text must refer to the table and / or graphs in question.
8. **Conclusions.** The conclusions should be brief, clear, to answer the stated aim and/or objectives. The conclusions must be based on figures.
9. **Recommendations** (if necessary).
10. **List of references.** It is recommended that the included scientific publications should be limited to the last 10 years and the number of references should not be less than 10. References have to be described according to the international APA guidelines. The citation of textbooks, brochures, popular magazines, advertising brochures and other similar sources is not acceptable. In the text of the article sources are cited in brackets indicating author's surname and year of publication, e.g.: (Cooper 2008), (Cleland, Kaufmann 2012). When the author is mentioned in the text, only the year is written in brackets, e.g.: "... as stated by N. Dagėlienė (2010)...". If the Internet source has no author, the reference is added only in the text in parentheses.
11. **Summary including keywords** is written in English, if the article is written in English, the summary is given in Lithuanian language. The length of a summary is 2000 – 2200 characters.

### Formatting requirements for articles

Articles should be written in *Microsoft Word*, the text should be typed on a single side of A4 (210 x 297 mm) format page at 1 line spacing, using 12 pt., *Times New Roman* font, alignment to both side (justify).

Other requirements:

1. **The width of margins:** Top – 2,5 cm, bottom – 2,5 cm, right and left – 2,5 cm.
2. **Headings of sections:** 12 pt., bold, aligned to the center. The indentation of the first line of the paragraph – 1 cm.
3. **The title of the article:** in 14 pt., capitals, bold, aligned to the center.
4. **Name, surname:** 12 pt., bold, aligned to the center.
5. **Name of an institution:** 12 pt., aligned to the center.
6. **Abstract:** text font –12 pt., alignment to both side (justify). An empty line should be left after the section..
7. **Introduction, methodology, results and conclusions:** 12 pt., alignment to both side (justify). There are no empty lines left after the headings.
8. **Figures:** Titles of figures (illustrations, drawings, graphs, diagram, photo) and in formation are presented in Lithuania and in English. The English text is written in italics. The named is centered, **is** placed under the picture. If the article is in English, the title not translated. The figures in the text must be numbered.
9. **Tables:** Titles of tables are presented in Lithuania and in English. The English text is written in italics, is placed above the table, centered. If the article is in English, the title not translated. Text in the tables is written in 10 pt. The tables in the text must be numbered.
10. **Literature (sources of information):** text size – 10 pt., alignment to both side (justify). Each source of information starts with a new line and is numbered.
11. **The title in English:** in capitals 12 pt., bold, centered.
12. **Abstract of article in English:** in 12 pt., alignment to both side (justify).
