

FINANCE: STUDENTS SURVEY RESULTS

2020–2021 y. Spring semester

REFERENCE PERIOD:

June 2021

AIM:

To study the *Finance* students' the opinion on study subjects / modules their quality, and teaching.

QUESTIONNAIRE:

Students studying at *Finance* study programme evaluated the quality of study subjects /modules according to 14 criteria. Rating scale: *Strongly Agree; Agree; Neither Agree nor Disagree; Disagree; Strongly Disagree*. Fifty-five completed questionnaires were received.

Finance study programme students have a positive perception of the study subjects / modules and the quality of their teaching in the spring semester of 2020-2021, as shown by 77% of the students who participated in the survey agreeing with the evaluation criteria.
