LAW: STUDENTS SURVEY RESULTS

REFERENCE PERIOD:

June 2019

AIM:

To study the *Law* students' the opinion on study subjects their quality, and teaching.

QUESTIONNAIRE:

Students studying at *Law* study programme evaluated the quality of study subjects according to 13 criteria. Rating scale: *Strongly Agree; Agree; Neither Agree nor Disagree; Disagree; Strongly Disagree.* Thirty-two completed questionnaires were received.

SURVEY RESULTS (N=32):

Law study programme students have a positive perception of the study subjects and the quality of their teaching in the spring semester of 2018-2019, as shown by 71% of the students who participated in the survey agreeing with the evaluation criteria.
