## ORDER FOR SETTING THE THE PAYMENT RATES FOR THE RENT OF THE DORMITORY ROOMS OF KAUNO KOLEGIJA

## I. The set prices for those who settled in the dormitory for more than two months

1. I s e t the payment rates for the rent of the dormitory rooms of Kauno Kolegija with common conveniences (when showers, WC and kitchen are placed for common use):

1.1. 56,00 Eur per month for one student if there are three students who live in a triple room;

1.2. 84,00 Eur per month for one student if there are two students who live in a triple room;

1.3. 168,00 Eur per month for one student if there is one student who lives in a triple room.

1.4. 56,00 Eur per month for one student if there are two students who live in a double room (Dormitory No 4)

1.5. 112,00 Eur per month for one student if there is one student who lives in a double room (Dormitory No 4)

2. I s e t the payment rates for the rent of the dormitory rooms of Kauno Kolegija with common conveniences (shower, kitchen, WC):

2.1. 98,00 Eur per month for the room if there is a kitchen, a shower and a WC in a block of multiple rooms;

2.2. 94,00 Eur per month for the room if there is a shower and a WC in a block of multiple rooms;

3. Iorder:

3.1. to calculate the monthly rent payment proportionally to the amount of days lived for those students of Kauno Kolegija and other schools of higher education who did not live the whole month;

3.2. to set the annual deposit of 90,00 Eur for all the inhabitants who form a rent agreement for no longer than a month. The deposit must be paid after settling in the dormitory.

3.3. to apply a monthly payment of 20,00 Eur to a student who wishes to maintain the place in the dormitory throughout the summer holidays (July/August).

3.4. to apply a monthly payment of 20,00 Eur to a student who is 25-years-old or younger and who has been provided a guardianship according to the Law before he reached the age of majority or if his parents are dead and who has the right to the guardianship allowance after having provided the relevant documents.

## II. The set prices for those who settled in the dormitory for no longer than two months

4. I set the payment rates for the rent of the dormitory rooms of Kauno Kolegija for those who have settled in temporarily:

4.1. 6,00 Eur (with value-added tax) per day for one place in the room with common conveniences (applies to the students of Kauno Kolegija);

4.2. 9,00 Eur (with value-added tax) per day for one place in the room in a block of multiple rooms (applies to the students of Kauno Kolegija);

4.3. 8,00 Eur (with value-added tax) per day for one place in the room with common conveniences (applies to others than the students of Kauno Kolegija);

4.4. 12,00 Eur (with value-added tax) per day for one place in the room in a block of multiple rooms (applies to others than the students of Kauno Kolegija).

5. Ioblige:

5.1. the inhabitants of the dormitories of Kauno Kolegija to pay their monthly rent before the 15<sup>th</sup> day of the current month;

5.2. the inhabitants of the private flats who settled in a dormitory to account for the monthly taxes according to the signed lease agreement and the utility bill;

5.3. a student can change the room if possible. The change is carried out on the first day of the next month;

5.4. a student from another institution of higher education or a guest is granted a place in a dormitory only after completely fulfilling the need of the students of Kauno Kolegija;

5.5. the accountancy office to carry out the accounting of income and expenditure for each dormitory separately.

6. I a p p o i n t the head of the accounting office to carry out the control of the order implementation

7. I o r d e r to apply the set payment rates (except for the one specified in the paragraph 3.3.) from the 1<sup>st</sup> of September 2019.

8. I o r d e r to apply the set payment rate which is specified in the paragraph 3.3. from the  $1^{st}$  of July 2019

8.1. I w i t h d r a w the order No 51-267 of the 27<sup>th</sup> July 2017 of the director from the 1<sup>st</sup> of September 2017 "For Setting the Payment Rates For the Rent of the Dormitory Rooms of Kauno Kolegija."
